

BOROONDARA POWER SELECTION PROTOCOL

ELIGIBILITY

- All 13U, 15U, 17U players trialing must participate in the Boroondara Netball Association throughout the year as a player, coach or umpire or have been in the Boroondara Power pathway.
- Open VNL Talent Squad trials are open to any player in the community and are **selected from VNL trials**.
- Be prepared to commit to weekly training and matches ie) netball is your priority
- Respect the competitive aspects of weekly team selection and court time in Representative netball teams
- Be prepared to sign a Player/Parent Agreement form - if selected - confirming your support of the coaches, umpires and the Association
- Submit a player profile form by the due date and attend all selections as required. Players unable to trial due to injury must **attend** with a **medical certificate** from a doctor or physiotherapist. Other apologies with appropriate reason must be received via email before the selections.

Please note that there is a financial commitment:

- 1) Uniform – dress, training shirt & tracksuit
 - 2) Netball Victoria state membership fee – this is an annual fee providing insurance for all Netball Victoria competitions
 - 3) Team fee \$350 per season – this includes coaching, indoor court hire, competition / umpire costs, Assoc Champs
- NOTE:** this fee partially covers player costs. The balance is subsidised by Boroondara Netball Association.

SCREENING DAY 13U & 15U

- The screening sessions are held OUTDOORS at the Boroondara Netball Centre, Macleay Park.
- All NEW players must attend the first screening day including current 13U moving up to 15U.

SELECTION PROCEDURE

- There are a minimum of 3 selectors rostered on for each trial with continuity of selectors for each age group throughout. All selectors are experienced Power / VNL coaches and are aware of the standards required for players.
- The court runs are prepared before the trial and will be placed up on the board at the start of the session so that players can see when / where they are required to take the court. Each run is approx. 10 minutes and there is then a straight changeover to the next run so players must be aware and ready.
- **If you decide not to trial after registering, it is essential that you let me know BEFORE the trial date as court runs are prepared before the trial and your name will be on the board.**
- Each player will be placed on runs in their first and second nominated position. Some will have more runs than others because there may be less applicants for these positions. All will have a minimum of 2 runs.
- Selectors may choose to make changes at any time and may also advise that you trial in a specific position that they feel may optimise your chances of selection
- Each selector will have a copy of the runs and will individually score each player's performance. Selectors will collate this information after each trial and forward their lists to us so that we can notify you of their decisions (by email).
- Coach reports of current Power players will be taken into consideration.
- Current power players are not permitted to wear their Power T-shirts / uniform to selections.

SELECTION RESULTS

- After each preliminary trial, ALL players will receive an **EMAIL** advising whether they are invited to attend the next trial OR that they have been unsuccessful and not required to attend further selections.
- After the final trial all players will receive an **EMAIL within 3 days** advising whether they have been offered a position OR whether they have been unsuccessful this year.
- Feedback regarding your selection performance will be available if you have been unsuccessful in the **FINAL** selection only.
- **PLEASE be aware that there may be some current Power players who are unsuccessful, particularly when moving up from top age to bottom age. No current player is automatically assured of selection.**

ACCEPTANCE OF POSITION

To accept and confirm the position offered by Boroondara Power, compulsory requirements are:

- 1) Signed Acceptance form and Player/Parent Agreement
- 2) Payment of fees

These must be received **within 7 days** of receiving your offer. *To be fair to those who have been unsuccessful and are anxiously awaiting a second round offer, PLEASE advise as soon as possible if you are not accepting your offer.* Second round offers will be made in the event that a selected player declines her position.
